Persons wanting to become a member of the Citizen On Patrol (COPs) program must meet the following criteria;

- 1. Be at least 18 years of age
2. Submit a completed and approved C.O.P. application to the appropriate Division Code Blue / C.O.P. Coordinator five days prior to attending a C.O.P. training course
3. Pass a background check
4. Complete the 4 hour C.O.P. training course
5. Possess a valid driver's license (to be able to conduct vehicle patrols)
6. Ensure their vehicle(s) meet all Texas Motor Vehicle Code legal requirements;
- Vehicle registration, inspection, proof of vehicle insurance (to be able to conduct vehicle patrols)

Persons wanting to become a member of the Code Blue in Schools program must meet the following criteria;

- 1. Complete the six requirements to become a C.O.P. member listed above
2. Complete the two hour Code Blue at Schools training course

NOTE: Applicants who have a Concealed Handgun License; COP members are not permitted to carry any type of firearm with them while involved in any Citizens On Patrol or Code Blue at Schools activities.
